## Rosson's Roundup

Our 12<sup>th</sup> day enrollment numbers are final, so I'll provide a brief overview. We have 890 undergraduates with 570 in Agricultural Economics and 320 in Agribusiness. Our largest option is Finance and Real Estate, with 335 students. We have 89 students in Food Marketing Systems, 75 in Rural Entrepreneurship and 65 in Policy and Economic Analysis. Our Agribusiness students are about evenly split between upper and lower levels. The graduate program has a total of 123 students enrolled. We have 67 PhD students, 31 master of agribusiness, 24 master of science and one non-degree seeking. Thanks to our Graduate and Undergraduate Offices for compiling this information and supporting our students.

Earlier this week, James Johnson, '86 visited the department to discuss his interests in supporting highimpact learning. James started his career with the Foreign Ag Service, USDA, then moved to the National Confectioners Association in Washington, DC to work in international marketing. After meeting with Kerry Litzenberg, we hosted a luncheon at the University Club. Two of our students, Maggie Branch and Jason Edmonson, talked about their experiences. Jason participated in the study abroad trip to Ghana, while Maggie conducted a faculty supervised research project. Both of the students did an excellent job of explaining how these high-impact learning activities changed their perspectives on their education and the world. Thanks to you both for doing such a great job! Thanks to Patrick Williams who organized this event and Fred Boadu and Senarath Dharmasena who also participated in the luncheon.

Aggie baseball starts this weekend, with the University of Rhode Island Rams in Aggieland for a three game series beginning Friday night. Aggie softball hosts the Texas A&M Invitational starting Friday with Butler, Iowa and Tulsa participating. Aggie basketball plays at Arkansas on Saturday.

#### Symposium on Agriculture & Applied Economics Research
