C. Program Statement

My teaching responsibilities are in management of food and agribusiness firms. I teach at undergraduate and master's levels, for a total of 9 credit hours (three course preparations) in 2020. Three of the 9 credit hours was an online course converted on an urgent basis due to COVID pandemic. I taught a section of First-Year Experience as a Directed Studies section, supervised 2 students in research Directed Studies, and supervised 13 Master of Agribusiness students in internships.

I taught an in-residence course in Land Economics in 2012 and 2013. From 1999 to 2002, I taught 3 course preparations per year as the MAB program was launched and I added a fourth course from 2003-2008 for the Agribusiness Ph.D. field specialization. From 1996 to 1997, I taught quantitative methods and macroeconomics (9 classroom hours per year, 2 preparations).

Learning-by-doing is emphasized in my courses, as the students draw on concepts, ideas, and skills from prior courses and apply them to practical business problems, frequently in team settings. My primary teaching goal is to improve students' communication skills regarding the application of economic and financial principles to business decision making.

Secondly, I seek to improve students' functionality within professional teams, using a variety of experiential learning techniques. I emphasize higher-order thinking skills as a result of my employment experience in government and industry, where I saw first-hand that fast learners and people who think for themselves will succeed.

Teaching initiatives for masters' and undergraduate courses

I use the case study method of teaching in masters' level and senior undergraduate courses, as is used in graduate business colleges. This approach engages student learning through real-world business problem-solving. Through structured classroom discussions, I guide the students to consider alternative approaches that can be used to arrive at conclusions from the case. The ability to choreograph case discussions while incorporating the use of financial calculations is one of my greatest teaching strengths. I select cases that expose students to issues related to internationalization of the food and financial services industries. Students in my undergraduate class scored well on the nationally-normed Critical Thinking Assessment Test administered by the Office of Institutional Assessment in 2009.

Other teaching activities

In addition to classroom teaching initiatives, mentoring of graduate students is also a part of my teaching responsibilities. In 2013 I began serving as the sole academic advisor to the students in the professional Master of Agribusiness degree program. I supervised 13 internships in 2020. Eighteen Master of Agribusiness students graduated during 2020 and I advised and assisted them in job placement.

Over my career, 22 graduate students completed their research studies under my direction, and two Honors undergraduate students (in 2000, 2019). One masters student graduated in 2016 in the non-thesis M.S.

I mentor and support students in experiential learning opportunities, including internships at an international agribusiness industry conference (2008-15) (Global Cold Chain Alliance), study abroad (2004, 2005, and 2013-18), in field study travels in the United States (1998 and 2001), and in Student Research Week projects (2000, 2005, 2011).

D. Courses Taught

Courses Taught at Texas A&M University:

Eight course preparations since 1996; currently teaching 4-5 courses on campus in alternate years. Additionally, developed two distance courses, teaching 1 and co-teaching 1 beginning Fall 2012.

AGEC 431 Cases in Agribusiness Financial Management (required undergraduate course: 3 hours). Developed as a new course for Writing-Intensive credit; taught one section in Spring and Fall semesters, 2005-2008 and 2019. Taught one section per year, 2009-2018; taught two semesters in 2019.

This capstone financial management course in the Agribusiness degree program provides students with an understanding of the links between finance and the strategic goals of the agribusiness firm. As a designated Writing-Intensive course, the curriculum has been approved at the university-level for developing students' writing skills within their major field of study. Upon completion of the course, students are able to use financial data to judge strengths or weaknesses in performance, and report those evaluations in written business memos. In addition, they can develop models and interpret them to predict the short-term and long-term outcomes from business strategies. Students apply their knowledge of financial tools from prior course work to real business decisions, using case studies and extensive discussion. Topics covered include financial analysis and planning, working capital management, capital budgeting, risk management, and the external credit and macroeconomic environment.

AGEC 619 Managerial Economics for Agribusiness (required graduate course: 3 hours) (teach one section annually, 2010-present.) Enrollment 37 during 2020. Delivered web-based in 2020.

The course provides entering students in the Master of Agribusiness with an introduction to the role of economics in management decisionmaking. Students apply graphical methods, algebra, and calculus to the solution of problems. Covers the basics of consumer demand theory and focuses on key elements from the theory of the firm. The emphasis is on firm-level problems and the theories of cost minimization, pricing, and strategic interaction. Game theory and dynamic models are utilized. At the completion of the course, students are able to apply economic principles to a current business problem in the food, feed, and fiber sector, and present the results of their collaborative work to their peers.

AGEC 630 Financial Analysis for Agribusiness Firms (required graduate course: 3 hours) (Developed as a new course; taught one section in Fall semester, 1999-2008; teach one section in alternating years, 2010-present.) Enrollment 16 during 2020.

This is a capstone course in the Master of Agribusiness program that provides students with an understanding of the links between finance and the strategic goals of the agribusiness firm. Students apply knowledge from prior course work to real business decisions, using case studies, in-depth team work on a strategic decision case, and extensive discussion. The emphasis on application of quantitative analysis reinforces student's core course work in analytical tools, including econometrics, forecasting, and simulation. From 2003 to the present, the major assessment technique is a team-based portfolio to report business-relevant research results. Subject-matter coverage includes financial analysis and planning, capital budgeting, risk management using Value at Risk, asset valuation, real options and investment strategy, and the external credit and macroeconomic environment.

AGEC 638 Managerial Economics for Regulatory Science (optional graduate course in Regulatory Science distance-delivered certificate program). (teach one section 2012-present).

AGEC 639 Comparative Global Standards in the Food System (optional graduate course in Regulatory Science distance-delivered certificate program) (teach one section 2012-2018).

AGEC 317 Quantitative Analysis in Agricultural Economics. Spring semester, 1997-1999, two sections (required undergraduate course: 3 hours)

AGEC 430 Macroeconomics and Agriculture. Fall semester, 1996-1997 (optional undergraduate course: 3 hours)

AGEC 431 (501) Cases in Agribusiness Financial Management (required undergraduate course: 3 hours) This course was not formally designated as a Writing-Intensive section. Taught one section in Spring semester and one section in Fall semester, 1999-2004.

AGEC 485 Field Study Tour to New York and Washington DC. Spring Break 1997 and 2001.

AGEC 485/685 Study Abroad: South Africa and Swaziland, Summer 2015-2018; Spain, Summer 2004; France FESIA, Summer 2005; Costa Rica (guest instructor 1 week) 2013.

AGEC 603 Land Economics (required graduate course for Master of Real Estate: 3 hours) (Taught one section 2012 and 2013.) The course provides an overview of the theoretical principles, policy instruments, and current practice of using economics in understanding real estate markets. Students will examine the market forces that influence location decisions for firms and households. The objective is to understand the basic economic concepts and tools needed to analyze land markets across the continuum of urban, suburban, and rural areas. We will analyze how these location decisions cumulatively shape the spatial structure of cities and land prices.

AGEC 695 (601) Frontiers in Agribusiness and Managerial Economics (required graduate course: 3 hours) (Developed as a new course; taught one section in Spring semester, 2003-2008.) The course is the second in the sequence of Ph.D. field courses in the agribusiness and managerial economics specialization. Explores advanced topics in the frontiers of scholarship. The learning objectives of this seminar-style course are to (1) enhance students' skills in critical analysis of topical research; and (2) to formulate an individual research plan involving testable hypotheses from a contemporary problem in agribusiness. The outcomes are demonstrated with a journal-quality paper that reports the model and its results in a manner appropriate for professional audiences.

Courses Taught at Universidad Internacional de Ecuador, in Quito, Ecuador:

Case Study Methods in Agribusiness Research and Teaching (Developed as a new course: adult education as Visiting Professor, Summer 2001 and Summer 2002.) Introduction to case study methods in agribusiness education and research for instructors and researchers. Covers alternative approaches to teaching and learning in graduate curriculum and justification for the case study approach. Presents research designs for case study investigations, methods of data collection, and elements of case study protocol for a research project. C. Program Statement

I study the relationship between risk-taking and the possibility of financial gain, with a particular focus on the risks related to food perishability, safety and quality. My research program goal is to understand the relationship between the values of risky assets, managerial decisions, and the performance of firms in the food system. In the last year I have assessed the performance of the refrigerated warehousing industry in North America with benchmarking studies, and a global analysis of the cold chain. Research monographs were provided to the industry readership.

As part of my studies of the global cold chain industries (warehouses, trucking, and logistics firms), I have developed unique performance indicators and disseminated the research in venues that influence business decisionmakers. My work has been vetted by investment bankers and industry review committees.

Since 2009, I have played a leadership role in collaborative research through the Agribusiness, Food, & Consumer Economics Research Center. I have been principal investigator on a share of the Center's external funds and co-PI on the dairy promotion checkoff study for the past seven years.
