Program Statement

Dr. Ribera has been employed by Texas A&M AgriLife Extension as a specialist since July 2005. Initially, Dr. Ribera's primary job responsibilities were in the area of crop farm management and risk analysis in District 12. Currently, Dr. Ribera is the International Trade and Transportation Specialist as well as the Director of the Center for North American Studies.

The international trade landscape presents additional opportunities and challenges for local producers and agribusinesses, such as expanded market opportunities, increased competition, and sanitary and phytosanitary issues. From 2007 to 2010, Dr. Ribera coordinated workshops, along with Dr. Ron Knutson, for the North America Agrifood Market Integration Consortium and the CAFTA-DR Agrifood Market Integration Consortium. The objective of these workshops was to foster agricultural market integration and minimize friction among trading partners through harmonization of policies, programs, and regulations. Since then, Dr. Ribera has been working extensively in the area on international agricultural trade mainly on specialty crops. Moreover, in 2007 Dr. Ribera was named Program Director for International Projects for the Agricultural and Food Policy Center, adding even more responsibilities on the international arena.

Summary of Program Development

International Trade – During his time in the Lower Rio Grande Valley (LRGV), Dr. Ribera has worked on several international trade issues, such as invasive species and pest coming from Mexico, the increase in inflow of Mexican produce by truck through the LRGV and along the U.S./Mexico border, immigration labor and water issues with between Mexico and U.S. on the usage of irrigation water from the Rio Grande. From 2006 to 2008, Dr. Ribera, along with Dr. Knutson, coordinated three market integration workshops, two for the NAFTA region and one for the CAFTA region. In each workshop approximately 60 country delegates from the government, industry and academia participated. Topics covered in the workshop included barriers to trade, sanitary and phytosanitary issues, country of origin labeling, transition policies towards freer trade, building successful supply chains, among others. A policy panel closed each workshop, where policy makers from each country discussed the changes that needed to happen in order to increase trade among trading bloc members. In 2014 Dr. Ribera moved to College Station and is currently working on economics impacts of increase produce imports from Mexico, food safety, potential increase trade with Cuba, impacts of new trade agreements, mainly Trans Pacific Partnership and Trans-Atlantic Trade and Investment Partnership.

Dr. Ribera has nine international trade or trade related journal articles, three Extension publications, 12 AgriLife Centers or other publications and two book chapters. In addition, since his move to College Station, Dr. Ribera has given 20 presentations on International Trade and Transportation.

- Farm and Risk Management During his time in the LRGV, Dr. Ribera has worked with row crop producers, mainly cotton, grain sorghum, corn, and sugarcane. Dr. Ribera was invited several times to give presentations on crop market outlook, variety selection and crop budgets. Dr. Ribera's expertise on risk and portfolio analysis helped producers to better understand the principles of portfolio analysis and applied them to variety and/or crop mixes. He has published a journal article and several extension reports on how to use portfolio analysis to manage variety selection. The W.R. Cowley Sugar House has changed the format of presenting productivity and profitability reports to its constituents due to the work that Dr. Ribera did for them on risk management.
- Organic and Locally Grown Farm Management Dr. Ribera has worked with socially disadvantaged farmers and beginner farmers in District 12. He has provided crop budgeting and financial analysis support to the Grow'n Growers program, an AgriLife Extension program that teaches low-income residents how to grow organic vegetables on their own properties, then sell them at the area's only organic farmers market. In addition, he has provided training on how to create an agricultural cooperative under the same Grow'n Growers program that resulted in the establishment of a farmers' cooperative

known as Familias Productores del Valle, or Family Producers of the Valley. Also, Dr. Ribera works with the Texas Rural Cooperative Center of the University of Texas PanAmerican and the Texas/Mexico Boarder Coalition with programs that target socially disadvantaged and beginner farmers in South Texas. In 2009, Dr. Ribera lead a multidisciplinary team to develop the Small Acreage Business Workshop Series, a set of four workshops that covers topics such as production, government funding and programs, food safety, and business planning and marketing. Since 2009, Dr. Ribera's team has had 53 workshop/trainings on small acreage production. In 2013, Dr. Ribera worked with the Women's Business Center conducting the four-workshop series to female entreprenuers. Finally, from 2011 to 2014 through two federal grants, the small acreage production initiative awarded eight scholarships per year for three years to South Texas College (STC) and Texas A&M at San Antonio students to work on small acreage organic production techniques and wildlife management.

• Carbon Markets/Climate Change – Dr. Ribera has worked on carbon markets due to increased concerns regarding climate change. Two extension reports and a journal article were written on how farmers and ranchers can benefit from the carbon markets. Moreover, Dr. Ribera has been invited 14 times to give presentations on the economics of carbon markets and climate change policy. He has published one journal article, four proceedings and extension, and one book review on the subject. Moreover, Dr. Ribera has coordinated one workshop to train county agents on carbon markets/climate change.

Program Statement

As a compliment to his Extension programming as International Trade and Transportation Specialist, Dr. Ribera has undertaken applied research in farm management, risk analysis, biofuel production, climate change and transportation issues along the U.S.-Mexico border. Most of the research work that Dr. Ribera has been involved is feasibility studies of biofuel production, water use efficiency, and food safety. In his research appointment with Texas A&M Transportation Institute, Dr. Ribera has been working on adding stochastic capabilities to models developed by TTI, as well as congestions at the U.S.-Mexico border.

Summary of Major Accomplishments

• International Trade – During his time in the Lower Rio Grande Valley (LRGV), Dr. Ribera has worked on several international trade issues, such as invasive species and pest coming from Mexico, the increase in inflow of Mexican produce by truck through the LRGV and along the U.S./Mexico border, immigration labor and water issues with between Mexico and U.S. on the usage of irrigation water from the Rio Grande. From 2006 to 2008, Dr. Ribera, along with Dr. Knutson, coordinated three market integration workshops, two for the NAFTA region and one for the CAFTA region. In each workshop approximately 60 country delegates from the government, industry and academia participated. Topics covered in the workshop included barriers to trade, sanitary and phytosanitary issues, country of origin labeling, transition

policies towards freer trade, building successful supply chains, among others. A policy panel closed each workshop, where policy makers from each country discussed the changes that needed to happen in order to increase trade among trading bloc members. In 2014 Dr. Ribera moved to College Station and is currently working on economics impacts of increase produce imports from Mexico, food safety, potential increase trade with Cuba, impacts of new trade agreements, mainly Trans Pacific Partnership and Trans-Atlantic Trade and Investment Partnership.

Dr. Ribera has nine international trade or trade related journal articles, three Extension publications, 12 AgriLife Centers or other publications and two book chapters. In addition, since his move to College Station, Dr. Ribera has given 20 presentations on International Trade and Transportation.

- Transportation Dr. Ribera's work with Texas A&M Transportation Institute (TTI) started before his relocation to College Station. The main area of collaboration was congestion on the Texas ports of entry. His work on the economic impact of increase flow of Mexican produce through Texas land ports of entry was useful to TTI researchers. Upon his arrival to College Station, Dr. Ribera immediately started working on TTI's T.R.E.N.D.S. model, which was designed to provide transportation planners, policy makers and the general public with tool to forecast revenues and expenses for the Texas Department of Transportation. The model was widely used among Metropolitan Planning Organizations and Dr. Ribera converted the model from deterministic to stochastic. In addition, Dr. Ribera has collaborated with TTI on estimating per mile cost of transporting grains by truck and he also serve as a member of the Freight Practice Management Team.
- Renewable Energy Feasibility Analysis Dr. Ribera has worked on several feasibility analysis of renewable energy, mainly ethanol and biodiesel production. Dr. Ribera traveled to Brazil, Argentina and Colombia several times to gather information on ethanol and biodiesel production. In addition, he worked closely with the W.R. Cowley Sugar House in the LRGV on gathering information for a feasibility study on sugarcane-based ethanol in South Texas using the Brazilian method. Over the years 13 feasibility analyses were done using a wide variety of feedstocks such as corn, sorghum, sugarcane, energy cane, miscane (miscanthus & sugarcane mix), castor oil, palm oil and algae. Dr. Ribera was the lead economist on feasibility analyses of cellulosic-based biofuel production using miscane and energy cane under four conversion processes as part of a partnership with Chevron Technology Ventures. Moreover, Dr. Ribera has also worked with Shell, BP, Abengoa, and Canergy of feasibility studies of biomass-based biofuel production. Dr. Ribera has given 57 presentations for clientele in Texas, the U.S. and overseas. He has published four journal articles, four book chapters, and 10 proceedings and extension reports on the economics of biofuels. Moreover, Dr.

Ribera has coordinated seven workshops to train county agents on the economics of renewable fuel.
